- **TEXAS HARRIS COUNTY:** Clerk Fee Schedule Real Property Filing Fee per Texas Local Government Code Section. 118.011: **\$18.00 for the first page and \$4.00 for each additional page**.
- <u>TEXAS TRAVIS COUNTY:</u> The Recording Division of the County Clerk is responsible for maintaining real property records in Travis County. The fee to record a deed is **\$26 for the first page of the document and \$4 for each additional page**. Each name to be indexed in excess of five will be \$0.25.
- <u>TEXAS CHAMBERS COUNTY</u>: The County Clerk is responsible for recording and maintaining real property records in Chambers County. To record a document, the fee is **\$26 for the first page and \$4 for each additional page**. Each name in excess of five to be indexed is \$0.25.
- <u>TEXAS GALVESTION COUNTY</u>: The County Clerk is responsible for recording and maintaining real property records. To record a deed or other real property document, the fee is **\$26 for the first page** and **\$4 each additional page.** For all or part of each attachment or rider size 8.5x11 inches, the fee is \$4.
- **TEXAS BRAZORIA COUNTY:** The County Clerk is responsible for recording and maintaining real property records in Brazoria County. To record the fee is **\$26 for the first page and \$4 each additional page.** Each additional name to be indexed, in excess of five names, is \$0.25.
- <u>TEXAS FORT BEND COUNTY:</u> The County Clerk is responsible for recording and maintaining real property records in Fort Bend County. To record a deed, deed of trust, affidavit, or other document, the fee is **\$13 for the first page and \$4 for each additional page**.
